BOARD MEMBERS REPORT

Mrs. Hellwarth – (1) Papa John proceeds – where are they designated? Proceeds go to Athletic Dept. (2) who cleans the mini busses – in need of cleaning. Mr. Rutherford – Dr. Doering will ensure the message is relayed immediately to have them addressed for cleaning

Mr. Rhoades – (1) requested a mileage report for full and mini size busses. Purpose is to identify current usage of full size busses and to project maintenance of both size busses (2) Would like to have a projected life expectancy of full and mini busses to compare to current usage (3) Cows – No cows have been sighted - curious as to the status. Money is available for the program what has caused the delays? Per Mr. Keesling several factors needed considered - waiting for the grass to begin to grow for feed - did not want to have them over the winter months – need good food sources to ensure heavier cows with better beef. Chartwells has requested 7 cows from the program.
