This contract is between the Nettle Creek School Corporation, Wayne/Henry Counties, and Braden Albert, a person who possesses the abilities of Technology Director.



This contract is between the Nettle Creek School Corporation, Wayne/Henry Counties, and Drew Cooper, a person who possesses the abilities of Treasurer.


