SUPERINTENDENT NEWS

Dr. Barrentine informed everyone that there have been discussion about possibly pushing the start of school back. He does not plan on moving forward with that. School will start on August 5th.

The plan is to have virtual academy to be seamless with in person classes. That means that teachers will not only be teaching in their classrooms but also running the virtual program.
