- What are 2-3 strengths of Nettle Creek Schools? Why do you see these as strengths?
- If selected, what would you hope would be the key accomplishments of Nettle Creek Schools during your service?
- What ideas do you have for marketing Nettle Creek Schools?
- What are the leadership responsibilities of school board members?
- What makes our Vision 2025 meaningful to you?
- As a board member, you frequently get to hear complaints and concerns from community members. Often, these concerns fall outside the parameters of your role as a board member. How do you see yourself handling these situations?
- Describe the ideal superintendent-school board member relationship?
- You each have one minute to share any final thoughts or ask any questions you have.

Each candidate was asked the same question as they took turns answering prior to moving to the next question.

The Board adjourned for a small recess to review personal notes. Adjourned at 7:27 pm.

**SELECTION OF SCHOOL BOARD MEMBER**

Sandi Schraub nominated Cody Sankey for School Board, District B. Shaun Lieberman nominated Ruthie LaMar for School Board, District B. No more nominations were made. Nominations were closed.

Cody Sankey is selected as School Board Member, District B.
